Terms and Conditions for 2026 Football Screening Lucky Draw

1. General

These terms and conditions ("T&Cs") apply to the 2026 Football Screening Lucky Draw ("Lucky Draw") organised and operated by The Kallang Group Pte. Ltd. (the "Company" or "Organiser"). By taking part in the Lucky Draw, the participants shall be deemed to have agreed to be bound by the terms and conditions of the Lucky Draw.

2. Eligibility

- a. This Lucky Draw is open to all registered members of The Kallang Kaki Programme who have checked in on-site to The Kallang Football Screening (the "Event") on the respective scheduled Event Days.
- b. The Company reserves the right, in its sole and absolute discretion, to disqualify any individual found to be ineligible or tampering with the process or the operation of the Lucky Draw or to be acting in violation any legislation.
- c. Employees of the Company, their immediate family members and any other parties directly involved in the organising, promoting and conducting of the Lucky Draw, are not eligible to participate in this Lucky Draw.

3. Lucky Draw Mechanics and Details

- a. Winners will be selected at random during the Lucky Draw segment held at half-time on each of the four (4) screening days - 15 July, 16 July, 19 July, and 20 July 2026 (each a "Event Day" and collectively the "Event Days").
- b. Only attendees who are present and checked in on the respective Event Day will be eligible for the day's lucky draw.
- c. Winners must be physically present at the time of the Lucky Draw. Winners who are not present at the time will forfeit the prize, and the Organiser reserves the right to select an alternative winner at its discretion.
- d. Winners are required to provide a proof of identity for verification and administrative purposes.
- e. Winners of the Lucky Draw on a previous Event Day may participate in subsequent draws on other Event Days, provided they are present and have checked in on that respective Event Day.
- f. The Company reserves the right to publish or display the names, photographs, videos or any likeness of the participants of the Lucky Draw for promotional, marketing, advertising and publicity purposes.
- g. Prizes consist of merchandise from Event partners and sponsors. Prizes are not transferable and are not exchangeable for cash, credit or kind. The Company shall not replace any prizes which are lost, stolen or damaged. The Company reserves the right, at any time in its sole and absolute discretion, to substitute, withdraw, add to or alter

any of the prizes offered without notice to the participants. All prizes are subject to the respective issuers' terms and conditions. The Company shall not be responsible in any way whatsoever for the validity, utility, suitability, usability or fitness for purpose of the prizes, which shall be the issuer's sole liability. Except to the extent that they may not be excluded by law, no representations, warranties, terms or conditions that are not expressly stated in these terms and conditions apply to this lucky draw nor in respect of the prizes and all implied warranties are excluded, including but not limited to, the implied warranties of satisfactory quality, merchantability or fitness for a particular purpose of any of the prizes. Prizes must be utilized within the specified validity period and no requests for extensions will be entertained.

- h. The Company reserves its rights to cancel and terminate the Lucky Draw at its sole and absolute discretion and without notice and further liability to any participant.
- i. The Company reserves the right to amend these Terms and Conditions without prior notice.
